**Overview**

The [U.S. Department of Justice \(DOJ\)](#), [Office of Justice Programs \(OJP\)](#), [Office for Victims of Crime \(OVC\)](#) is seeking applications for funding that demonstrate innovative strategies to create, expand, or enhance the use of technology in innovative ways to interact directly with crime victims and/or to provide information, referrals, crisis assistance, and longer-term help. This program furthers the Department's mission by supporting organizations that encourage the use of technology to improve responses, services, and access for victims of crime.

## Program Description

### Overview

The Department of Justice is committed to advancing work that promotes civil rights, increases access to justice, supports crime victims, protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

Through this solicitation, OVC seeks to provide funding to organizations that demonstrate innovative strategies to create, expand, or enhance the use of technology in innovative ways to interact directly with crime victims and/or to provide information, referrals, crisis assistance, and longer-term help.

### Statutory Authority

34 U.S.C. § 20103(c)(1)(A)

### Specific Information

Through this program, OVC will support initiatives to maximize the use of technology to improve and increase access to crime victim services. Funding under this initiative may support technology development and maintenance; the staff required to operate, update, and maintain the proposed platform or service; training and technical assistance on the purpose and use of the technology (including outreach and publicity activities); and staff engaged in coalition-building activities regarding the use of technology. This funding should not supplant or duplicate currently funded initiatives in these areas. Applicants who propose to use this funding for ongoing, rather than new, initiatives must specify how these funds would be used to expand or enhance current services while not duplicating existing efforts.

### Goals, Objectives, Deliverables, and Timeline

#### Goals

Purpose Area 1: The goal of this program is to develop innovative strategies to create, expand, or enhance the use of technology to improve response, services, and access for victims of crime.

Purpose Area 2: The goal of this program is to enhance or expand capacity of a national victim service hotline.

#### Objectives

Purpose Area 1: The objective of this program is to identify gaps in technology that can be enhanced by building the organization's technological capacity to increase access and provide timely victim services that are sustainable, safe, and align with [OVC Model Standards](#).

Purpose Area 2: The objective of this program is to expand a national hotline to interact directly with crime victims and/or to provide information, referrals, crisis assistance, and longer-term help. The hotline should be staffed by experienced case managers who provide direct service provision and personalized support to crime victims, using trauma-informed approaches that protect the safety and confidentiality of victims. The hotline, at a minimum, should incorporate the following approaches:

- Utilize skilled case managers who can assess the needs of the victim and identify relevant next steps.
- Identify appropriate reporting agencies, and provide information to callers to assist them in reporting, or connect callers directly (as a warm hand-off) with the appropriate agency.
- Provide resources and referrals to other applicable services as needed.
- Provide contact information to national or local level resources per the specific needs of the caller.

#### Deliverables

Purpose Area 1 deliverables include:

- direct service provision to crime victims, using trauma-informed approaches that protect the safety and confidentiality of victims;
- development of culturally and linguistically appropriate community outreach events and/or materials and resources for service providers and criminal justice stakeholders; and,
- a final report describing project activities, promising practices, challenges encountered, and solutions to address those challenges in order to improve outcomes for crime victims

Purpose Area 2 deliverables include:

- Development of culturally and linguistically appropriate community outreach events and/or materials and resources for service providers and criminal justice stakeholders.
- Engagement in public awareness campaigns and easily accessible webinars to increase awareness of the assistance available.

The Goals, Objectives, and Deliverables are directly related to the performance measures that demonstrate the results of the work completed, as discussed under Application and Submission Information.

### Evidence-Based Programs or Practices

OJP strongly emphasizes the use of data and evidence in policymaking and program development in criminal justice, juvenile justice, and crime victim services. For additional information and resources on evidence-based programs or practices, see the [OJP Grant Application Resource Guide](#).

The Department of Justice is committed to advancing work that promotes civil rights, increases access to justice, supports crime victims, protects the public from crime and evolving threats, and builds trust between law enforcement and the community. In FY 2021, OJP will give priority consideration in award decisions to applications that demonstrate ways in which their projects will advance one or more of these areas.

To receive priority consideration for advancing one or more of the Department's priorities, the applicant must provide a sufficient narrative explanation as an attachment, that specifies how the project will advance the promotion of civil rights, access to justice, support to crime victims, protecting the public from crime and evolving threats, or building trust between law enforcement and the community.

In addition, OJP will give priority consideration, if applicable, to applicants that demonstrate that the individuals who are intended to benefit from the requested grant reside in high-poverty areas or persistent-poverty counties.

To receive priority consideration under the poverty priority, the applicant must provide information to demonstrate that the individuals who are intended to benefit from the requested grant reside in high-poverty areas or persistent poverty counties. For purposes of this priority consideration, the term "high-poverty area" means any census tract with a poverty rate of at least 20 percent as measured by the 2013–2017 5-year data series available from the American Community Survey of the Census Bureau (applicants may search by census tract at <https://www.census.gov/acs/www/data/data-tables-and-tools/narrative-profiles/2017/>) and the term "persistent poverty counties" means any county that has had 20 percent or more of its population living in poverty over the past 30 years, as measured by the 1990 and 2000 decennial censuses and the most recent Small Area Income and Poverty Estimates (applicants may search by county at <https://www.census.gov/data/tables/time-series/dec/census-poverty.html> and at <https://www.census.gov/programs-surveys/saipe.html>).

Priority consideration is one of many factors that OJP considers in making funding decisions and is not a guarantee of an award.

#### Proposal Abstract

A proposal abstract (no more than 400 words) summarizing the proposed project including primary activities, products and deliverables, the service area, and who will benefit from the proposed project, will be completed in the JustGrants Web-based form.

#### Proposal Narrative

The proposal narrative should be submitted as an attachment in JustGrants. The attached document should be double-spaced, using a standard 12-point Times New Roman font; have no less than 1-inch margins; and should not exceed 25 pages. Pages should be numbered and submitted as an attachment. If the proposal narrative fails to comply with these length restrictions, OVC may negatively consider such noncompliance in peer review and in final award decisions.

The following sections must be included as part of the proposal narrative:

- a. Statement of the Problem if research is involved
  1. Describe why this project and proposed activities are necessary (significance/value) and/or address a need and include supporting information.
  2. Describe how funding will support the project's value to the victims' field by meeting the stated goals. An applicant should use data to provide evidence that the need for the effort exists and demonstrate the scope and size of the need. The applicant should also make a convincing case that the project addresses a gap in existing resources and does not duplicate an existing program.
- b. Project Design and Implementation
  1. Describe the strategy to address the needs identified in the Statement of the Problem.
    - State the key goal(s) of the project.
    - Identify specific, measurable, achievable, relevant, and time-based (SMART) objectives to accomplish goal(s).
    - List the proposed project activities and describe how they relate to the stated objectives. Activities are the specific actions to be undertaken to fulfill the objectives and reach the goal(s).
    - Provide a detailed description of the method(s) to be used to carry out each activity.
    - Describe interim deliverables and final products.
    - Provide a timetable indicating roughly when activities or project milestones are to be accomplished. The time-task plan should be presented in chart form as a separate attachment and will not be subject to the proposal narrative page limitation.
  2. Identify any potential challenges to the project's success, and describe how the applicant will mitigate those challenges.
  3. Describe how the safety and confidentiality of victims will be protected.
  4. Describe any sustainability measures the applicant will take to continue its efforts beyond the funding period.

The project strategy and time-task plan for developing technology-based projects that enhance services to victims of crime should cover the duration of the 36-month project period.

- c. Capabilities and Competencies

1. Applications must describe the capabilities and competencies to accomplish the goals and objectives of the project. It must also include a clear description of the applicant's management structure and current and proposed professional staff members' unique qualifications that will enable them to fulfill their grant responsibilities. Applicants must describe how the program will be managed and include an organizational chart or information describing personnel.
2. Applicants must also include a list of personnel responsible for managing and implementing the major stages of the project. If additional staff will be hired to complete the project, the applicant should identify the selection criteria. The project director must have both the substantive expertise and experience to perform crucial leadership functions, and sufficient time to devote to the project to provide the needed guidance and supervision. Job descriptions and copies of resumes for proposed key staff positions should be included as a separate attachment

- d. Plan for Collecting the Data Required for this Solicitation's Performance Measures

Applicants must include the following information:

- Describe the process for measuring project performance.
- Identify who will collect the data and who is responsible for performance measurements.
- Describe how the information will be used to guide and evaluate the impact of the project.
- Describe the process to accurately report data

OJP will require each successful applicant to submit regular performance data that demonstrate the results of the work carried out under the award. The performance data directly relate to the goals, objectives, and deliverables identified under "Goals, Objectives, and Deliverables" in the Program Description.
