INTRODUCTION

Purpose of Document

This document provides an overview of current federal funding opportunities. It is designed to highlight key information to help jurisdictions evaluate whether to pursue these opportunities. Please refer to the linked Notice of Funding Opportunities (NOFO) as the official source of guidance on application procedures, eligible and allowable expenses, and deadlines. If a funding opportunity appears relevant to your plans, carefully review the NOFO to ensure all requirements are addressed. Many Department of Justice funding opportunities involve a two-step application process, each with its own deadline. These deadlines are detailed within the descriptions.

Audience

The grant programs outlined in this document are open to a range of eligible applicants, including state, local, and tribal government entities, as well as nonprofit organizations. Eligibility varies by program, so it is essential to review the eligibility criteria. If your jurisdiction or organization does not qualify to apply directly, many programs permit and even encourage partnerships through sub-grants or contracts with eligible applicants.

Grant Program Priorities

Please note that many grant programs identify program-specific priorities. See specific instructions in each notice of funding to determine what information is required to receive the priority consideration. This resource will note if a NOFO indicates that there is rural priority or a rural-specific category. The priorities are defined as follows:

Office of Justice Programs Funding Priorities

The Office of Justice Programs will provide priority consideration to applicants that propose projects designed to advance the goals listed below. Applicants seeking priority consideration should specify in the proposal narrative (and in the budget detail form, if applicable) which of the following goal(s) the project is intended to advance and how it will do so: (a) Directly supporting law enforcement operations (including immigration law enforcement operations); (b) Combatting violent crime; (c) Supporting services to American citizens; (d) Protecting American children; and (e) Supporting American victims of trafficking and sexual assault.

Rural-Specific Category

This specifies whether a grant program includes a funding category exclusively for rural jurisdictions. Be aware that each program generally defines "rural jurisdiction" differently, so it is important to carefully review each NOFO to confirm whether your jurisdiction or target audience qualifies. If applicable, the specific language regarding rural categories is included in the grant program description.

Rural Priority

This identifies whether a grant program includes additional priority language prioritizing funding for rural jurisdictions. If applicable, the specific rural priority language is provided in the grant program description.

Description:

This program supports state, local, and tribal law enforcement and prosecution agencies in identifying, investigating, prosecuting, and preventing hate crimes. Funding is intended to enhance investigative and prosecutorial capacity, including technical, forensic, and legal support. The program also prioritizes coordinated, multi-jurisdictional approaches and efforts to address serial violent hate crime offenses.

What can be funded?

Funding may be used for:

- Hate crime investigation and prosecution support
 - Technical, forensic, and prosecutorial assistance
 - Case development and evidence analysis
- Prevention and identification efforts
 - Strategies to improve identification and reporting of hate crimes
 - Training for law enforcement and prosecutors
- Multi-jurisdictional coordination (Category 2)
 - Regional or statewide collaboration across agencies
 - Coordination among multiple jurisdictions
- Training and capacity building
 - Law enforcement training on recognizing and investigating hate crimes
 - Prosecutorial training on applicable laws
- Victim support enhancements
 - Tools and approaches to improve outcomes for victims
- Addressing serial hate crimes
 - Efforts targeting repeat offenders and patterns of violence

Description:

This program provides funding to support state, local, and tribal governments, law enforcement agencies, and correctional institutions in developing, implementing, or expanding training programs that improve responses to individuals in crisis. These crises often involve behavioral health conditions, intellectual and developmental disabilities, physical disabilities, or traumatic brain injuries. The program emphasizes equipping officers with practical de-escalation strategies, crisis intervention techniques, and emerging technologies (such as virtual reality) to enhance safety outcomes, reduce use of force, and improve both public and officer wellbeing.

What can be funded?

There are two categories of funding:

Category 1: Training Program for Law Enforcement Officers

Category 2: Training Program for Correctional Officers

Allowable activities focus on training development, implementation, and expansion, including:

- Development or expansion of de-escalation and crisis response training programs
- Implementation of Crisis Response and Intervention Training (CRIT)
- Acquisition and integration of virtual reality (VR) training systems for scenario-based learning
- Training for:
 - Law enforcement officers (field-based)
 - Correctional officers and facility staff
 - Probation and parole personnel
- Development of customized, immersive training scenarios
- Enhancing coordination with behavioral health providers
- Use of evidence-based curricula and training models
- Planning, monitoring, and evaluation support (including use of consultants)

Description:

This funding program supports jurisdictions in developing, enhancing, and expanding treatment court models that serve individuals with substance use disorders involved in the justice system. These courts integrate judicial supervision with evidence-based treatment, drug testing, and coordinated support services to address the underlying drivers of criminal behavior. The program emphasizes improving long-term recovery outcomes, reducing recidivism, and preventing overdose deaths through structured, collaborative court and treatment interventions.

What can be funded?

There are 3 categories of funding available based on the status of a program:

- Category 1: Planning and Implementation
- Category 2: Enhancement
- Category 3: Statewide

The following types of services can be funded:

- Behavioral health treatment
- Recovery supports (housing, peer, employment)
- Court operations and supervision
- Training
- Data Collection and analysis

Description:

This funding program supports the development, implementation, or expansion of comprehensive programs in response to overdose deaths, illicit opioids, stimulants, and other substances. Through this program, state, territorial, local, and tribal governments can support law enforcement-related activities, including efforts to locate and investigate illicit activities related to the unlawful distribution of opioids; increase access to prevention programs and overdose reversal medications; and expand treatment and recovery support services in the community, within correctional facilities, and upon reentry.

What can be funded?

There are 3 categories of funding available:

- Category 1a: Local Applications (Urban area or large jurisdiction)
- Category 1b: Local Applications (Suburban area or medium-size jurisdiction)
- Category 1c: Local Applications (Rural jurisdiction)
- Category 2: Statewide Applications; Eligible state applicants include either the State Administering Agency (SAA), the State Alcohol and Substance Use Agency, or other state agency deemed appropriate to coordinate and manage the planning and implementation of the proposed project.
 - State applicants must apply for funding on behalf of six or more jurisdictions or areas (including localities, judicial districts, tribal entities, or regions affected by increases in substance use) within the state. The state must assume responsibility for the management, oversight, and evaluation of all projects identified.
 - State applicants must also include a research and evaluation partner as part of its application.
- Category 3: Tribal Applications

Funds can be used for:

- Law enforcement–led prevention, enforcement, and diversion efforts, including investigating illicit opioid distribution, first responder diversion programs, and embedding social services with law enforcement.

- Alternative-to-incarceration and court-based treatment programs, including pre- and post-booking diversion, family and treatment courts, and expedited access to recovery services.
- Evidence-based treatment and recovery supports, including medications for opioid use disorder (MOUD), peer support, and transitional or recovery housing (subject to funding caps).
- Overdose prevention and community education initiatives, including naloxone distribution and training, K–12 prevention programs, and public awareness efforts.
- Prescription drug safety and data systems, including drug take-back programs and real-time regional data collection, analysis, and information sharing.

The program emphasizes a family-centered, cross-system approach that integrates child welfare, treatment providers, and the courts to promote reunification and long-term stability.

What can be funded?

There are 3 categories of funding available:

- Category 1: Establishing New Family Treatment Courts
- Category 2: Enhancing Family Treatment Courts
- Category 3: Statewide or Countywide Family Treatment Courts Expansion

The following types of services can be funded:

- Treatment Services
- Child/family support services

The program focuses on improving behavioral health outcomes, reducing reoffending, and strengthening connections between youth, families, and community-based services.

What can be funded?

- Youth treatment services
- Family engagement
- Court coordination

Description:

This funding program supports the implementation and enhancement of specialized court dockets that serve justice-involved veterans with substance use, mental health, and trauma-related conditions. These courts combine judicial oversight with coordinated treatment and recovery services tailored to veterans, including addressing post-traumatic stress disorder and traumatic brain injury. The program aims to improve public safety and individual outcomes by connecting veterans to appropriate care while reducing recidivism and promoting sustained recovery.

What can be funded?

There are 3 categories of funding available based on the status of a program:

- Category 1: Planning and Implementation
- Category 2: Enhancement
- Category 3: Statewide

The following types of services can be funded:

- Behavioral health care
- Peer recovery
- Court operations
- Statewide improvements

Description:

This program provided funding to strengthen the capacity of rural law enforcement agencies and prosecutors' offices to prevent, respond to, and reduce violent crime. The program supports the development and implementation of targeted, data-driven violent crime reduction strategies that address specific local challenges. Emphasis is placed on equipping rural jurisdictions—often constrained by limited resources—with technology, personnel, training, and analytic capabilities needed to improve public safety outcomes.

What can be funded?

Funding supports comprehensive, strategy-based approaches to violent crime reduction in rural communities:

1. Technology Enhancements
 - Hardware, software, and communications systems
 - Intelligence centers and data-sharing infrastructure
 - Tools that improve officer safety and operational efficiency
2. Personnel, Training, and Equipment
 - Hiring or supporting personnel tied to crime reduction strategies
 - Training on modern policing tactics and approaches
 - Equipment such as:
 - Records management systems
 - Vehicles, vests, and firearms
 - Focus on targeted deployment to high-crime areas or individuals
3. Data Analytics and Intelligence
 - Crime analysis tools and software
 - Staff or consultants to support data analysis
 - Predictive analytics to identify hotspots and high-risk times/locations
 - Enhancing resource allocation strategies
4. Strategy-Based Approaches
 - Jurisdiction-specific violent crime reduction plans
 - Regional or multi-agency collaboration models
 - Focus on specific crime types such as:
 - Homicide, assault, robbery
 - Gun violence
 - Human trafficking
 - Gang-related crime
 - Intimate partner violence

Capital Case Litigation Initiative: Improving the Quality of Legal Representation in State Capital Cases

Description:

This program provides funding to strengthen the quality and effectiveness of legal representation in state capital cases by supporting both prosecution and defense systems. The program requires states to invest equally in enhancing prosecutors' capacity to represent the public and improving defense services for indigent individuals facing capital charges or sentences. Through training, system improvements, standards development, and case review processes, this initiative aims to reduce errors in capital litigation, ensure competent legal representation, and improve fairness and integrity across the capital case system.

What can be funded?

Funding supports system-level improvements for both prosecution and defense functions in capital cases:

Capital Prosecution (Prosecutor-Focused Activities):

- Development and delivery of specialized training and resources for prosecutors
- Establishment of standards and qualifications for capital case prosecutors
- Performance assessment systems for prosecutors
- Implementation of error-reduction strategies in capital trials
- Systematic case reviews, including identifying cases for post-conviction DNA testing
- Victim services and support, including assistance to families of homicide victims

Capital Representation (Defense-Focused Activities):

- Establishing or enhancing effective systems for indigent defense in capital cases
- Providing legal counsel and necessary support services (investigators, experts, etc.)
- Supporting representation for:
 - Individuals charged with capital offenses
 - Individuals sentenced to death seeking appeals or collateral relief
 - Individuals seeking review in the U.S. Supreme Court
- Developing qualification standards and rosters for defense attorneys
- Expanding training, support, and resources for defense counsel

Cross-Cutting Requirements:

- Funding must be equally allocated between prosecution and defense
- At least 75% of defense funding must support trial-level representation for indigent defendants

Investigating and Prosecuting Sexual Assaults in Confinement Facilities Program

Description:

This funding program supports state, local, and tribal efforts to strengthen the investigation and prosecution of sexual assault in confinement facilities. The funding is intended to improve investigative and prosecutorial capacity, reduce incidents of sexual assault in confinement settings, and increase the rate of successful prosecutions. The NOFO is closely tied to the goals of the Prison Rape Elimination Act (PREA) and emphasizes stronger coordination among correctional institutions, law enforcement agencies, and prosecutors.

What can be funded?

- Investigative and prosecutorial infrastructure
 - Establishing or expanding investigative and prosecutorial activities specifically focused on sexual assault in confinement facilities.
 - Enhancing operational capacity to process, review, and pursue cases involving sexual assault in jails, prisons, or other confinement settings.
- Evidence development and case support
 - Supporting evidence collection, preservation, and retention efforts needed to strengthen investigations and prosecutions.
 - Improving victim and witness interviewing practices to build stronger cases and improve case outcomes.
- Training and professional development
 - Educating and training law enforcement, prosecutors' offices, and partner agencies on how to respond to, investigate, and prosecute sexual assault in confinement settings.
- Coordinated response models
